2022 LTA ADVANTAGE WIMBLEDON BALLOT RULES

Introduction

The following ballot rules must be adhered to by all Advantage Members seeking to enter the LTA Advantage Wimbledon Ballot administered by the Lawn Tennis Association (the "LTA"), and apply in addition to the LTA's general ballot terms and conditions applicable to all ticket ballots administered by the LTA, a copy of which are available here ("Terms"). In the event of a conflict between these rules and the Terms, these rules shall prevail. Please ensure that you read these rules and the Terms carefully prior to entering the LTA Advantage Wimbledon Ballot.

Eligibility

To be eligible for the LTA Advantage Wimbledon Ballot, an Advantage Member will need one of the following active tiers up until 23.59 on 28 February 2022:

• Play+ (11+ for Junior Play+); or Compete (11+ for Junior Compete); or Fan+

How to enter

Advantage members must Opt In through their secure Advantage online area, accessed with their username and password. Opt In will be open from 10 January 2022 to 4 February 2022, with no Advantage Member able to Opt In after Opt In has closed.

Multiple Ballots

LTA Advantage Members are only entered once in to the LTA Advantage Wimbledon Ballot (including where a member holds multiple categories of membership at the same time, for example Play Plus and Fan Plus). However, if Advantage Members are eligible for other LTA ballots, they will be able to enter those ballots and may be successful in winning another pair(s) of tickets in addition to entering and being successful in the LTA Advantage Wimbledon Ballot.

Winners

The LTA Advantage Wimbledon Ballot will start on 1 March 2022, and successful Advantage Members will be contacted by email within 30 days of such date with details of the tickets that will be made available for them to purchase from the LTA or its designated ticketing services provider. Winners who purchase tickets will be subject to the LTA's terms of sale, made available to them at the time of purchase. Advantage Members will not be offered further tickets in the LTA Advantage Wimbledon Ballot if they decline, miss a deadline or pay for tickets.

2022 LTA ACCESSIBLE SEATING WIMBLEDON BALLOT RULES

Introduction

The following ballot rules must be adhered to by all Advantage Members seeking to enter the LTA Accessible Seating Wimbledon Ballot administered by the Lawn Tennis Association (the "LTA"), and apply in addition to the LTA's general ballot terms and conditions applicable to all ticket ballots administered by the LTA, a copy of which are available here ("Terms"). In the event of a conflict between these rules and the Terms, these rules shall prevail. Please ensure that you read these rules and the Terms carefully prior to entering the LTA Accessible Seating Wimbledon Ballot.

Eligibility

To be eligible for the LTA Accessible Seating Wimbledon Ballot, an Advantage Member will need one of the following active tiers up until 23.59 on 28 February 2022:

• Play+ (11+ for Junior Play+); or Compete (11+ for Junior Compete); or Fan+

How to enter

Advantage members must Opt In through their secure Advantage online area, accessed with their username and password. Upon Opting in, Advantage Members must state their accessible seating requirements (Wheelchair or Ease of Access). Advantage Members are not allowed to Opt In to the LTA Accessible Seating Wimbledon Ballot on behalf of a guest – the Advantage Member who has Opted In to the LTA Accessible Seating Wimbledon Ballot must themselves require a Wheelchair space or Ease of Access seating. Opt In will be open from 10 January 2022 to 4 February 2022, with no Advantage Member able to Opt In after Opt In has closed.

Multiple Ballots

LTA Advantage Members are only entered once in to the LTA Accessible Seating Wimbledon Ballot (including where a member holds multiple categories of membership at the same time, for example Play Plus and Fan Plus). However, if Advantage Members are eligible for other LTA ballots, they will be able to enter those ballots and may be successful in winning another pair(s) of tickets in addition to entering and being successful in the LTA Accessible Seating Wimbledon Ballot. Upon entry to other LTA Ballots, entrants will be able to list any accessibility requirements, however will not be entered in to a separate accessible ballot.

Winners

The LTA Accessible Seating Wimbledon Ballot will start on 1 March 2022, and successful Advantage Members will be contacted by email within 30 days of such date with details of the tickets that will be made available for them to purchase from the LTA or its designated ticketing services provider. Winners who purchase tickets will be subject to the LTA's terms of sale, made available to them at the time of purchase. Advantage Members will not be offered further tickets in the LTA Accessible Seating Wimbledon Ballot if they decline, miss a deadline or pay for tickets.

Tickets

An LTA Advantage Member may only be assigned a maximum of one pair of tickets (based on stated requirements) through the LTA Accessible Seating Wimbledon Ballot. A wheelchair space will include a complimentary seat for a carer. Please note that once tickets have been purchased by an Advantage Member they cannot be transferred. This includes (but is not limited to) selling or giving tickets to friends, family or other Advantage Members. The tickets must be used by the LTA Accessible Seating Wimbledon Ballot winner and a guest only (the guest does not need to be an Advantage Member). Any ticket advertised or offered for sale, or otherwise transferred, whether by the participant or any third party, will be void.

2022 LTA COACHES WIMBLEDON BALLOT RULES

Introduction

The following ballot rules must be adhered to by all LTA Accredited+ Coaches seeking to enter the LTA Coaches Wimbledon Ballot administered by the Lawn Tennis Association (the "LTA"), and apply in addition to the LTA's general ballot terms and conditions applicable to all ticket ballots administered by the LTA, a copy of which are available here ("Terms"). In the event of a conflict between these rules and the Terms, these rules shall prevail. Please ensure that you read these rules and the Terms carefully prior to entering the LTA Coaches Wimbledon Ballot.

Eligibility

To be eligible for the LTA Coaches Wimbledon Ballot Coaches must have an active Accredited+ accreditation up until 23.59 on 28 February 2022. Coaches in their Accredited+ grace period are not eligible.

How to enter

Accredited+ Coaches must Opt In through their secure Advantage online area, accessed with their username and password. Upon entering, Accredited+ Coaches will be able to list up to 3 day preferences that they would prefer tickets on or select an any day option. Opt In will be open from 10 January 2022 to 4 February 2022, with no Accredited+ Coach able to Opt In after Opt In has closed. If an Accredited+ Coach does have any accessibility requirements they will be able to list these at the point of Opt In. Whilst they will not be put in to a separate accessible seating ballot, if they are successful in the ballot we will try to meet their requirements the best we can.

Multiple Ballots

LTA Accredited+ Coaches are only entered once in to the LTA Coaches Wimbledon Ballot. However, if LTA Accredited+ Coaches are eligible for other LTA ballots, they will be able to enter those ballots and may be successful in winning another pair(s) of tickets in addition to entering and being successful in the LTA Coaches Wimbledon Ballot.

Winners

The LTA Coaches Wimbledon Ballot will start on 1 March 2022, and successful Accredited+ Coaches will be contacted by email within 30 days of such date with details of the tickets that will be made available for them to purchase from the LTA or its designated ticketing services provider. Winners who purchase tickets will be subject to the LTA's terms of sale, made available to them at the time of purchase. Accredited+ Coaches will not be offered further tickets in the LTA Coaches Wimbledon Ballot if they decline, miss a deadline or pay for tickets. Whilst a day preference is available to Accredited+ Coaches, we cannot guarantee that we will be able to supply winners with a ticket on a day they have requested.

Tickets

An LTA Accredited+ Coach may only be assigned a maximum of one pair of tickets through the LTA Coaches Wimbledon Ballot. Please note that once tickets have been purchased by an Accredited+ Coach they cannot be transferred. This includes (but is not limited to) selling or giving tickets to friends, family or other Accredited+ Coaches. The tickets must be used by the LTA Coach Wimbledon Ballot winner and a guest only (the guest does not need to be an Accredited+ Coach). Any ticket advertised or offered for sale, or otherwise transferred, whether by the participant or any third party, will be void.

2022 LTA VOLUNTEERS WIMBLEDON BALLOT RULES

Introduction

The following ballot rules must be adhered to by all LTA Venue Volunteers seeking to enter the LTA Volunteers Wimbledon Ballot administered by the Lawn Tennis Association (the "LTA"), and apply in addition to the LTA's general ballot terms and conditions applicable to all ticket ballots administered by the LTA, a copy of which are available here ("Terms"). In the event of a conflict between these rules and the Terms, these rules shall prevail. Please ensure that you read these rules and the Terms carefully prior to entering the LTA Volunteers Wimbledon Ballot.

Eligibility

To be eligible for the LTA Volunteers Wimbledon Ballot an LTA Venue Volunteer must be linked to a venue and be registered on the venues workforce with the following criteria up until 23.59 on 28 February 2022:

- A qualifying Advantage Membership tier in order to be linked to the venue (Play+ membership is free when you are a member of the venue); and
- Any venue role and type of work listed as volunteer or the venue role listed as volunteer.

How to enter

LTA Venue Volunteers must Opt In through their secure Advantage online area, accessed with their username and password. Opt In will be open from 10 January 2022 to 4 February 2022, with no LTA Venue Volunteer able to Opt In after Opt In has closed. If an LTA Venue Volunteer does have any accessibility requirements they will be able to list them at the point of Opt In. Whilst they will not be put in to a separate accessible seating ballot, if they are successful in the ballot we will try to meet their requirements the best we can.

Multiple Ballots

LTA Venue Volunteers are only entered once in to the LTA Volunteers Wimbledon Ballot. However, if LTA Venue Volunteers are eligible for other LTA ballots, they will be able to enter these ballots and may be successful in winning another pair(s) of tickets in addition to entering and being successful in the LTA Volunteers Wimbledon Ballot.

Winners

The LTA Volunteer Wimbledon Ballot will start on 1 March 2022, and successful LTA Venue Volunteers will be contacted by email within 30 days of such date with details of the tickets that will be made available for them to purchase from the LTA or its designated ticketing services provider. Winners who purchase tickets will be subject to the LTA's terms of sale, made available to them at the time of purchase. LTA Venue Volunteers will not be offered further tickets in the LTA Volunteers Wimbledon Ballot if they decline, miss a deadline or pay for tickets.

2022 LTA OFFICIALS WIMBLEDON BALLOT RULES

Introduction

The following ballot rules must be adhered to by all LTA Licensed Officials seeking to enter the LTA Officials Wimbledon Ballot administered by the Lawn Tennis Association (the "LTA"), and apply in addition to the LTA's general ballot terms and conditions applicable to all ticket ballots administered by the LTA, a copy of which are available here ("Terms"). In the event of a conflict between these rules and the Terms, these rules shall prevail. Please ensure that you read these rules and the Terms carefully prior to entering the LTA Officials Wimbledon Ballot.

Eligibility

To be eligible for the LTA Officials Wimbledon Ballot LTA Licensed Officials must have the following criteria up until 23.59 on 28 February 2022:

- · Hold an active LTA license; or
- Be in the grace period of the LTA Officials License.

How to enter

LTA Licensed Officials must Opt In through their secure Advantage online area, accessed with their username and password. Opt In will be open from 10 January 2022 to 4 February 2022, with no LTA Licensed Official able to Opt In after Opt In has closed. If an LTA Licensed Official does have any accessibility requirements they will be able to list the at the point of Opt In. Whilst they will not be put in to a separate accessible seating ballot, if they are successful in the ballot we will try to meet their requirements the best we can.

Multiple Ballots

LTA Licensed Officials are only entered once in to the LTA Officials Wimbledon Ballot. However, if LTA Licensed Officials are eligible for other LTA ballots, they will be able to enter these ballots and may be successful in winning another pair(s) of tickets in addition to entering and being successful in the LTA Officials Wimbledon Ballot.

Winners

The LTA Officials Wimbledon Ballot will start on 1 March 2022, and successful LTA Licensed Officials will be contacted by email within 30 days of such date with details of the tickets that will be made available for them to purchase from the LTA or its designated ticketing services provider. Winners who purchase tickets will be subject to the LTA's terms of sale, made available to them at the time of purchase. LTA Licensed Officials will not be offered further tickets in the LTA Officials Wimbledon Ballot if they decline, miss a deadline or pay for tickets.

2022 LTA YOUTH SCHOOLS WIMBLEDON BALLOT RULES

Introduction

The following ballot rules must be adhered to by all LTA Youth Schools seeking to enter the LTA Youth Schools Wimbledon Ballot administered by the Lawn Tennis Association (the "LTA"), and apply in addition to the LTA's general ballot terms and conditions applicable to all ticket ballots administered by the LTA, a copy of which are available here ("Terms"). In the event of a conflict between these rules and the Terms, these rules shall prevail. Please ensure that you read these rules and the Terms carefully prior to entering the LTA Youth Schools Wimbledon Ballot.

Eligibility

A School will need to join the LTA Youth Schools programme for free to be eligible for the LTA Youth Schools Ballot. A school can join at any time and be eligible but will only be able to Opt In during 29th November 2021 to Midday 27th January 2022 (the "**Opt In window**").

How to enter

An LTA Youth School must Opt In through their secure LTA Youth online area, accessed with their email and password. Upon entering, LTA Youth Schools will be able to list up to 3 day preferences that they would prefer tickets on or select an any day option. LTA Youth Schools will also be able to express an interest in a pack of full price Centre Court Tickets. Opt In will be open during the Opt In window, with no LTA Youth School able to Opt In after Opt In has closed. If an LTA Youth School has any pupil they wish to bring who requires any form of accessible seating, they must contact the LTA on ticketing@lta.org.uk.

Winners

The LTA Youth Schools Wimbledon Ballot will start on 1 March 2022, and successful LTA Youth Schools will be contacted by email within 30 days of such date with details of the tickets that will be made available for them to purchase from the LTA or its designated ticketing services provider. LTA Youth Schools who purchase tickets will be subject to the LTA's terms of sale, made available to them at the time of purchase. Whilst a day and Centre Court preference is available to LTA Youth Schools, we cannot guarantee that we will be able to supply winners with a pack of tickets on a day or court they had requested. LTA Youth Schools will not be offered further tickets in the LTA Youth Schools Wimbledon Ballot if they decline, miss a deadline or pay for tickets.

Tickets

An LTA Youth School may only be assigned a maximum of one pack (5 pairs – 10 tickets in total) of tickets through the LTA Youth Schools Wimbledon Ballot. Tickets are available on No.1, No.2 and No.3 Court at 50% discount and also on Centre Court at full price. A pack of tickets will all be on one court situated together.

Tickets must be used as part of an organised school trip following all guidelines that the local authority and school have set for number of adults supervising pupils. Pupils must be supervised at all time whilst inside The Championships. LTA Youth Schools cannot return a single pair of tickets for a refund. If they wish to request a refund it must be for all tickets included in the pack.

Please note that once tickets have been purchased by an LTA Youth School they cannot be transferred. This includes selling or giving tickets to friends, family or other LTA Youth Schools. The tickets must be used by the LTA Youth Schools Wimbledon Ballot winner. Any ticket advertised or offered for sale, or otherwise transferred, whether by the participant or any third party, will be void.
