LTA Colleague Wimbledon ticket acceptance form

By purchasing tickets I understand that if I, or anyone I share tickets with, breach any of the conditions below, or the AELTC Conditions of Sale, I will be subject to disciplinary action and will not be permitted to take part in future Colleague Ballots.

Ticket conditions

(For the avoidance of doubt, "ticket" refers to Ground Passes **and** Show Court tickets).

I understand and agree that:

- I will not sell my tickets or advertise tickets for sale anywhere. In doing so, my tickets would be void and I will be subject to disciplinary action.
- I will not advertise the availability of tickets (for sale or for free) on any social media platforms or social networking sites.
- I will not, under ANY circumstances, take photographs of my tickets or allow photographs or copies of my tickets to be taken. I will not share or post pictures of my tickets anywhere, including on any social media platforms or social networking sites.
- I will not swap my tickets with, or give my tickets to, an LTA colleague.
- I am able to share my tickets with close friends and family and it is okay for them to reimburse me for the face value of the ticket.
- If I give Ground Passes or Show Court tickets to friends or family, I will make sure that they fully understand that the tickets are for their use only, that they must not pass these tickets on to anyone else, and that they must not take or share photographs of the tickets, or sell or advertise the tickets for sale in line with the restrictions above. I will also make them aware of the 'Friends and family conditions of ticket use' to make this clear to them.
- I will not give my tickets to people I do not know.
- If I, or close friends / family cannot make use of my tickets, I will ensure that they are returned to the Colleague Ballot team so that they can be redistributed via formal channels.
- I am responsible for the conduct of anyone attending The Championships, Wimbledon, using tickets that originated from me. If they breach any of the AELTC conditions, or the conditions below, I may be subject to disciplinary action by the LTA and will not be permitted to take part in future Colleague Ballots.
- My tickets cannot be used for commercial reasons or as prizes (such as a raffle prize, lottery prize or school ballot) or for charitable reasons (such as a donation) and I will not offer them as such to anyone or any organisation.
- My tickets are subject to the full Conditions of Entry which can be found on the official website of The Championships at wimbledon.com and which are also available on application. If I, or anyone using my tickets, breach those Conditions of Entry, I understand that the AELTC shall be entitled to refuse admission or eject me or those using my tickets from the grounds of The Championships without refund or compensation.

- If another colleague offers me tickets for work purposes (i.e. to help distribute them quickly if they are 'going spare') I will refuse them and advise my colleague to return the tickets to the original source, so that they can be redistributed through the proper channels.
- If I use social media to promote our sport, I will use my discretion in the process and adhere to the guidance provided by the LTA and AELTC.
- If I have any doubts regarding the use of my tickets, I will speak to the Colleague Ballot team in the first instance to ensure that I am complying with this guidance, the AELTC Conditions of Sale and Conditions of Entry.
