



Tennis Wales Mascot Design Competition - Terms & Conditions

1. Eligibility

1.1 The Tennis Wales Mascot Design Competition (“Competition”) is open to children aged 12 years and under on Sunday 12th January 2025.

1.2 Participants must have permission from their parent or guardian to enter the Competition.

1.3 The Competition is open to residents of Wales only.

2. Entry Requirements

2.1 All entries must be the original work of the participant.

2.2 Entries should be created using the **Tennis Wales Mascot Template** provided by Tennis Wales.

2.3 Each entry must include the following details:

a. The proposed **Name of the Mascot**

b. **Participant’s Name**

c. **Participant’s Age**

2.4 Submissions must be made by emailing a completed design to

TennisWales@TennisWales.org.uk with the subject line: “This is my Mascot”.

2.5 Entries must be submitted by **23:59 (GMT) on Sunday 12th January 2025**. Late entries will not be considered.

3. Competition Timeline

3.1 **Launch Date:** Thursday 24th October 2024

3.2 **Contest Close Date:** Sunday 12th January 2025

4. Judging Criteria

4.1 Entries will be reviewed by a panel composed of Tennis Wales staff, Youth Ambassadors, a professional designer, and members of the Welsh Tennis community.

4.2 The judging will be based on the following criteria:

a. **Creativity & Originality**

b. **Representation of Tennis & Welsh Heritage**

c. **Visual Impact & Appeal**

4.3 The decision of the judging panel will be final and binding. No correspondence regarding the results will be entered into.

5. Prizes

5.1 First Prize:

5.2 Runners-Up Prizes (3 Winners):

5.3 Prizes are non-transferable and cannot be exchanged for cash or other alternatives.

6. Intellectual Property & Usage Rights

6.1 By entering the Competition, participants agree that Tennis Wales will have the right to use, modify, and publish the winning mascot design in all forms of media and marketing materials, in digital, print & any other formats.

6.2 The winner's design may be altered by the Tennis Wales professional design team to ensure suitability for use in various formats.

6.3 The participant retains ownership of their original design, but Tennis Wales will hold exclusive rights to use the winning mascot for official purposes without permission of the participant.

7. Parental Consent

7.1 As participants are under 12, parental or guardian consent is required for all entries. By submitting an entry, parents or guardians confirm that they agree to these terms and conditions and grant permission for the child's participation.

8. Privacy

8.1 Tennis Wales will collect and use personal data (such as the participant's name and age) for the purpose of administering this Competition.

8.2 By entering, parents/guardians consent to Tennis Wales publishing the name of the winning child and their age along with the mascot design.

9. General Conditions

9.1 Tennis Wales reserves the right to cancel, suspend, or amend the Competition or these terms and conditions where it becomes necessary to do so.

9.2 Participants who fail to comply with these terms and conditions will be disqualified.
